## 21 CFR PART 11 Compliance

CQRM XD Compliance Builder with Real Time Monitoring is a cost-effective solution that provides 21 CFR Part 11 compliance with minimal system and operator changes. The system records all actions pertaining to data being secured, thus providing an independent and secure audit trail with date and time stamp and identification of the user who initiated the action. This audit trail is captured contemporaneously as the data event happens, which serves as evidence from the time raw data is created, and any subsequent data events (data addition, deletion, modification) that took place, thereby providing integrity of data and transparency.



The system has the ability to capture electronic signatures for all data events, which also helps eliminate the need to print and maintain paper records with wet signatures.

### Flexible and Configurable Security Options

CQRM XD Compliance Builder with Real Time Monitoring provides complete This includes the ability to enable functionality such as managing eSignatures, user sign-offs or even setting up email alerts for specific data folders (or all folders), with no impact or interference to any application performance.

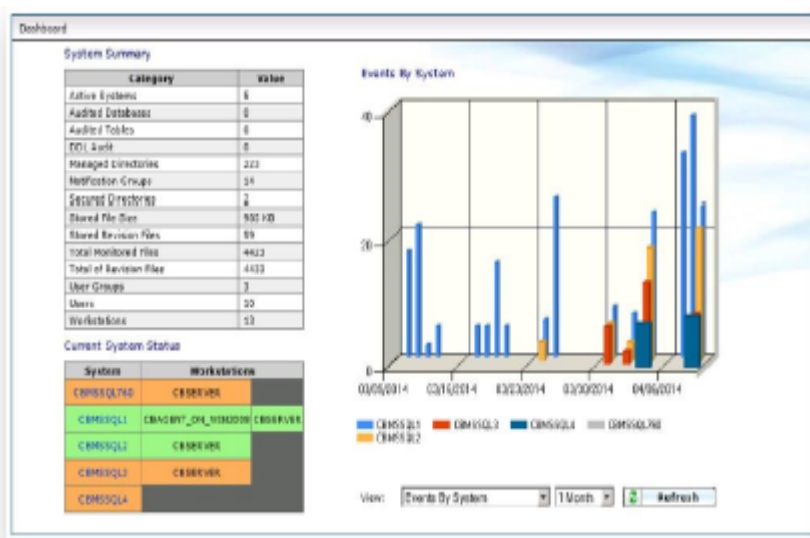


Figure 1. Dashboards provide insight into important compliance deviations, log files and events.

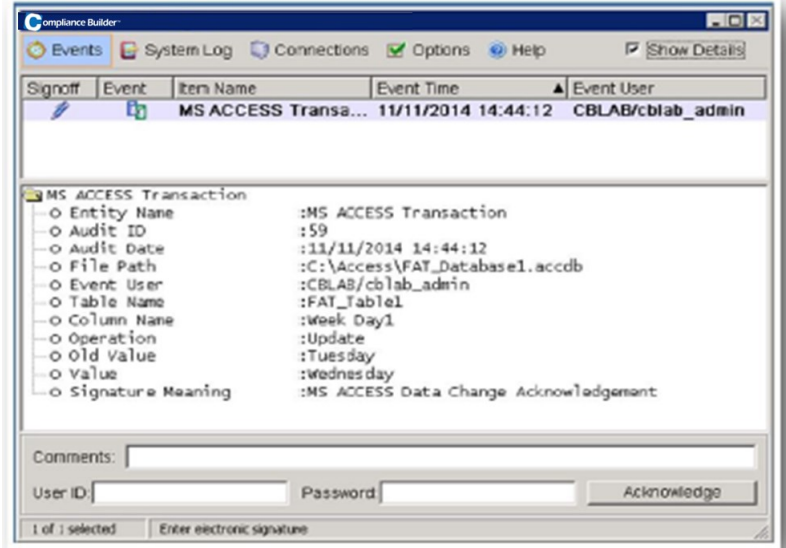


Figure 2. Compliance Builder supports flexible transaction monitoring on

**Microsoft® SharePoint Monitoring and Fraud Detection:** CQRМ XD Compliance Builder with Real Time Monitoring has a SharePoint module that provides capabilities designed to monitor the SharePoint library and send the appropriate notifications when document downloads from the configured library exceed the specified average usage by a user. Upon detection of any abnormality in the usage pattern, an alert email is sent to mitigate risk and allow for appropriate action from stakeholders to prevent any data leak from the system.
